

# Camper Code of Conduct

The Rocky Mountain District and Region 8 are proud to sponsor Harmony Camp and we are very pleased to have you attend as a camper. In order to ensure that your experience is safe and enjoyable, we require all campers to abide by a strict code of conduct. Lack of adherence to these policies constitutes grounds for expulsion. We have a **zero tolerance** policy.

- The use or possession of fireworks, firearms, ammunitions or any dangerous ordnance or weapons of any kind are strictly prohibited.
- All campers are required to refrain from smoking at any time during camp.
- All campers are required to refrain from the use of foul language at anytime during camp.
- Use of non-prescription medications or legally prohibited drugs including alcohol is strictly prohibited.
- There are to be no male campers on the sleeping floors in the women's dorm at any time for any reason.
- There are to be no female campers on the sleeping floors in the men's dorm at any time for any reason.
- All campers are to be at the scheduled place at the scheduled time. No one leaves the group without a camp appointed chaperone.
- Campers are not authorized to leave the YMCA grounds at any time.
- Campers are to be in the dormitory rooms and lights are to be out by 11:15pm. The only exception is a medical emergency.
- Campers may not leave the YMCA at any time without permission of the Camp Administrator, notice to Counselor, and signing out with the camp administrator.
- Campers are expected to follow the instructions of camp faculty and counselors.
- Campers are expected to follow the facility rules as issued by the YMCA.

## **Dress Code:**

We take pride in the appearance of our campers. We believe the way a person dresses has an effect on her/his behavior. Campers' dress and grooming are the responsibility of the camper. Campers will not be permitted to wear clothing styles and/or jewelry that are disruptive, detrimental or injurious to the purpose of the educational program of the camp. Clothing that does not adequately cover the body or allows undergarments to be shown is considered inappropriate dress; this includes "sagging" of pants and no bare midriffs. As a general guideline, shorts or skirts should not be shorter than finger tips when the arm and fingers are fully extended down the sides of the leg. Any clothing which advertise or promote alcohol, drugs, sex, tobacco, violence, and obscene or questionable language are not permitted. The administration reserves the right to have them call home, or borrow appropriate clothing when their dress is deemed inappropriate for participation in camp or is disruptive to the learning environment.

**Failure to abide by this code of conduct may result in the immediate expulsion from camp. If you are expelled from camp for non-compliance to any of these rules, your parents/guardians will be notified and will be responsible for the inconvenience and expense of your immediate retrieval.**
